SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application - Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Funds will be utilized to prioritize school culture, social-emotional support of our students, and fill in student achievement gaps that were created due to the COVID-19 pandemic. All areas in which funding will be implemented aligns directly with our district's priority on student and staff safety, and CDC guidelines. Students and staff members participating in summer, weekend, after-school, and tutoring programs will be required to wear masks and remain adequately socially distanced. New staff members will receive in-depth training on our school's COVID-19 safety protocols, and all new technology purchased will be properly sanitized between student usage. Daily cleaning throughout the school day of high traffic areas will continue to be a priority in addition to nightly deep cleaning of classrooms. The district's HVAC air filtration system has been upgraded to increase air circulation and ventilation throughout the school. As an added layer of safety, we will continue to provide our students with safety dividers while eating, send out student and staff health surveys and conduct temperature checks upon student, staff, and visitor arrival.

4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.

Student needs will be measured and monitored throughout the school year. Students with high achievement gaps were identified at the end of last year and were asked to participate in our summer school program. Assessments and data were collected throughout the course of our program utilizing the SANY database. Our database allows each child's progress to be monitored closely and in detail until the student reaches a level of mastery on all standards. Utilizing the standardized learning structure helps teachers to create an intervention plan for each student and group them according to their ability level. This data is then used towards targeted interventions within the classroom and through tutoring programs. With strong parent communication and support, tutoring opportunities will expand beyond the school day and into weekend and evening sessions for students in need. Students will continue to receive assessments during the course of the year, and teachers will gather data to monitor growth or assign alternate supports. In order to ensure that our school has the ability to offer a wide range of support for our students, we will be using the majority of the funding to employ Academic Intervention Specialists, additional Teaching Assistants, Behavior Specialists, and Counselors.

5. In the space provided below, please describe how the LEA will use the funds it reserves under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year.

The impact of lost instructional time will be addressed through district-wide after-school programs, Saturday school, after-school tutoring, and summer school. A district-wide six-week extended day summer school program has already been held. Enrolled students attended summer school five days a week for six hours a day. Teachers focused on closing academic achievement gaps and supporting our students' social-emotional needs during this time. Our school was also able to provide breakfast and lunch for all students, and transportation for those in need. Students will receive targeted and small group interventions during the school day, and also outside of school hours to substitute for the previous year's lost instructional time. Students in need will be identified based on absenteeism and assessment scores.

Funding will be used to hire additional academic staff and to purchase technology for our school. Hired positions will include Intervention Teachers, Academic Intervention Specialists, Co-teachers, Technology Coordinators, and Teaching Assistants. Counselors will be hired for social-emotional needs, and behavior specialists will be available to support and mentor our students. These positions will ensure that the added programs and services that our students will be receiving this year will be properly staffed. Technology that is purchased through these funds will be for student Chromebooks. Additional Chromebooks will allow our school to have a 1:1 student and technology ratio. Our district has partnered with the community organization North Side learning center to provide outside support. SANY has also created its own model of culturally responsive teaching. All teachers receive summer institute PD on how to implement this into their classrooms. In addition to this, teachers receive emotional poverty training to better understand and address our special ed. population student needs. During summer institute McKinney-Vento will be provided and teaching staff will be trained by our district liaison. Our district also uses a variety of assessment tools to monitor student growth and tie intervention directly to our data. Programs that allow us to track student growth include iReady, STAR, and Fountas, and Pinnell.

Through the utilization of our intervention programs iReady, STAR, and Fountas and Pinnell, interventions are able to be tailored to students' needs on a regular basis. Students are able to receive the necessary support and fill in achievement gaps. Parent liaisons help our district to ensure that our community and parents know the opportunities that are available within our school that allow us to serve our students. Our district works hard to also develop new and existing partnerships with community organizations that serve our students outside of the school day. For example, North Side Learning Center is working with our schools to provide some services within their facility for our students and their families. 100 Black Men is also a community organization that serves as a mentor for our students. SANY is also committed to our student's character education. Teaching and focusing on the whole child is part of our mission and dedication to our students. Having a staff that is trained on McKinney-Vento and incorporating Culturally Responsive Teaching into their classroom daily helps to ensure that all student needs are met. Our district also has behavior specialists and certified counselors that will be on alert this year and fully available to our students. They conduct one on one check-ins with students, regular building walkthroughs, pull small groups, and work with families to address both in-school and at-home needs.
